What Is Linguistic Lie Detection?

Statement:

• The information a subject is willing to give.

Analysis:

• Ability to examine the information and determine its truthfulness or deception.

Why Use It?

- To get the information from the subject.
- To determine its truthfulness or deception.
- To understand what information the subject is actually giving you.
- So the interviewer does not reveal what they do not know.



Subject Sets the Tone

The subject sets the tone for the interview.

We receive more information by analyzing the patterns of speech given by the subject.

Only then do we know what the pressure points are for the subject. Dick Cheney Interview

- JAMIE GANGEL: In your view, we should still be using enhanced interrogation?

What to Ask for in a Statement

 Ask the subject to write down everything from the time he/she woke up to the time they went to sleep.

Analysis Basics

 Statements will usually be in the first person, past tense format.

Disclaimer:

 Although this is a brief introduction to Statement Analysis, it should in no way be used in place of additional training.

Pronouns

- Pronouns include: I, my, we, you, he, she, it, my, your, them, they, us, their, our, etc.
- Pronouns can help determine if the subject acted alone or with someone else.
- Disputes about possession.
- Missing pronouns indicate the subject's lack of commitment to that particular statement.

Social Introductions

• The other people in the statement are important to take note of.

 The way the subject introduces them can determine their significance to the subject and to the events at hand.

Gary Condit interview with Connie Chung

Social Introduction:


Chung: Did she want you to leave your wife?Condit: No, I mean, I've been married for 34 years, and I intend to stay married to that woman as long as she'll have me.

At no time after this was Mr. Simpson asked if he killed only one person.




- What does her testimony reveal?

Non Answers are Answers


Jay Leno interviewed Hillary in 2003 after the release of her biography
